1. Transport Infrastructure Directorate has received budget from Provincial Government for the Procurement of Steel Wire Ropes. Transport Infrastructure Directorate intends to apply part of the funds to cover eligible payments under the Contract for Procurement of Steel Wire Ropes, **Contract Identification No: TID/BAG/ICB/G/01/079/080** Bidding is open to all eligible Bidders from all countries.
2. Transport Infrastructure Directorate (TID) invites electronic bids from eligible Bidders for the procurement of Steel Wire Ropes under International competitive Bidding – **Single Stage Two Envelope**.
3. For the procurement of Steel Wire Ropes IFB No. **TID/BAG/ICB/G/01/079/080** individual Bidder must be a manufacturer of Steel Wire Ropes. In case of JV, Partner-in-charge must be manufacturer of Steel Wire Ropes.
4. Eligible Bidders may obtain further information and inspect the Bidding documents at the office of TID, Hetauda, Bagmati Province or may visit PPMO eGP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
5. Bidder must submit their bid electronically. Bidders should download the Bidding documents for e- submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders should deposit the cost of Bidding document **NRs. 5000.00** (In Words: Nepali Rupees: Five Thousand Only. in the following Rajaswa (revenue) account as specified below.

6. Pre-bid meeting shall be held at Transport Infrastructure Directorate, Hetauda at **12 noon 8 June 2023**
7. Electronic bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12 noon on 19 June 2023**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1.00 PM** on **19 June 2023** at the office of **Transport Infrastructure Directorate, Hetauda, Nepal**
9. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **US\$. 13000** (In Words: United States Dollar: Thirteen Thousand Only), which shall be valid for 30 days beyond the validity period of the bid i.e. **17 October 2023**.
10. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
